EXTENSION AGREEMENT

THIS AGREEMENT Made and entered into this 12 day of June 1942, by and between Farmers and Merchants State Bank of Winterset, Madison County, Iowa, party of the first part, and Cora Gay Dunmire and James W. Dunmire, wife and husband, of Newton, Jasper County, Iowa, party of the second part.

WHEREAS, Cora Gay Dunmire and James W. Dunmire are justly indebted to said Farmers and Merchants State Bank in the sum of Six Hundred Fifty & No/100 DOLLARS (\$ 650.00) secured to be paid by a certain note and mortgage, executed by said Cora Gay Dunmire and James W. Dunmire the 1st day of July 1937, payable to First National Loan & Title Co. of Jasper County, Iowa on the 1st day of July 1942, with interest at the rate of 5 per cent, payable semi-annually; which said mortgage was duly recorded in the Recorder's office of Madison County, Iowa, in Book 88 of Mortgages on Page 169, and which note and mortgage were later assigned to Farmers and Merchants National Bank of Winterset and subsequently assigned to Farmers and Merchants State Bank.

WHETEAS, \$650.00 of the principal sum of said note is still unpaid and the said Cora Gay Dunmire and James W. Dunmire party of the second part, hereto has applied to said Farmers and Merchants State Bank for the extension of said note of Six Hundred Fifty & No/100 Dollars for a term of three (3) years from 1st day of July 1942.with interest at the rate of five (5) per cent per annum, payable semi-annually,

NOW THEREFORE, in consideration of the faithful performance of all the covenants in said note and mortgage, as well in spirit as in letter, and the payment of interest to this date, said first party hereby agrees to postpone and extend the time of payment of said note to the lst day of July, 1945. Option granted party of the second part to pay \$100 or any mulitple thereof on the principal of said note on any semi-annual interest paying date.

It is also expressly understood and agreed by and between the parties hereto that nothing herein contained shall operate to discharge or release the said Cora Gay Dunmire and James W. Dunmire and/or their heirs, legal representatives, or assigns, from the liabilities to fulfill, keep and promptly perform, as well in spirit as in letter, each and all of the covenants in said mortgage and note given by said Cora Gay Dunmire and James W. Dunmire

It is further expressly understood by and between the parties hereto, that in case of default in any of the covenants or conditions in said note or mortgage, then at the election of said first party, heirs or assigns, the whole of principal sum shall at once become due and payable and said note shall draw interest at seven per cent from such default and the mortgage may be foreclosed as stated in said mortgage, anything hereinbefore contained to the contrary notwithstanding.
