EXTENSION AGREEMENT

THIS AGREEMENT made-and entered into this 24th day of March 1943, by and between Helen McCall Huntoon and her husband, H. V. Huntoon, of the County of Madison, and State of Iowa, present owners of the premises described in the mortgage hereinafter mentioned, parties of the first part, and the Union State Bank, Winterset, Madison County, Iowa, party of the second part;

witnesseth: Whereas, Helen McCall Huntoon and her husband, H. V. Huntoon, did execute and deliver unto the Union State Bank, Winterset, Iowa, a certain mortgage and note therein set forth, said mortgage bearing date the 19th day of February, 1938, which mortgage was recorded in mortgage record 89, at page 29, of the records of the County Recorder of Madison County, Iowa, to secure the payment of said note in full amount of Twenty-seven Hundred Fifty (\$2750.00) Dollars and interest; and

Whereas, Helen McCall Huntoon and her husband, H. V. Huntoon, are the present owners of the property described in said mortgage, and the Union State Bank, Winterset, Iowa, the present owner of said note and mortgage, have this day agreed to extend the time of payment of the principal sum of said note secured by said mortgage;

NOW, THEREFORE, FOR VALUE RECEIVED, it is hereby agreed that the principal sum now fully and justly unpaid on the note secured by said mortgage is Twenty-seven Hundred Fifty (\$2750.00) Dollars, and that the same draws and is to draw interest at the rate of five per cent per annum, payable semi-annually, to be computed from the first day of March, 1943, and the principal sum shall become due and payable as follows, to-wit:

Merch 1, 1948, at which time the parties of the first part hereby assume and agree to pay and discharge same with all costs and expenses as well as interest accrued or to accrue at the Union State Bank, Winterset, Iowa, and the party of the second part does by these presents, consent and agree to the extension of said mortgage indebtedness as above set forth.

It is also mutually agreed that all the terms, conditions, and stipulations in said note and mortgage contained and set forth are and shall continue in full force and effect, excepting only as modified by the foregoing agreement.
