EXTENSION AGREEMENT

THIS AGREEMENT made and entered into this 5th day of January, 1943, by and between Georgia G. Zink and S. B. WITNESSETH: Whereas, Georgia G. Zink and S. B. Zink, wife and husband, did execute and deliver unto the Union State Bank, Winterset, Iowa, a certain mortgage and note therein set forth, said mortgage bearing date the 16th day of December, 1938, which mortgage was recorded in mortgage record 89, at page 202, of the records of the County Recorder of Madison County, Iowa, to secure the payment of said note in the full amount of Three Hundred (\$300.00) Dollars and interest; and

It is also mutually agreed that all the terms, conditions and stipulations in said note and mortgage contained and set forth are and shall continue in full force and effect, excepting only as modified by the foregoing agreement.
