PARTIAL ASSIGNMENT OF MORTGAGE

The undersigned, C.H.Gilbert, as Administrator of the Estate of E.S.Gilbert, Deceased, No. 4487 Probate, in Madison County, Iowa, District Court, do hereby sell, transfer and assign unto Etta Gilbert, widow of said E.S.Gilbert, an undivided one-third (1/3) interest in and to an undivided one-half (1/2) interest in a certain mortgage, dated December 1, 1924, made and executed by Glen Wolfe and Lela B.
