to The Federal Land Bank of Omaha, of Omaha, Nebraska, on the real property situated in the County of Madison State of Iowa described therein,

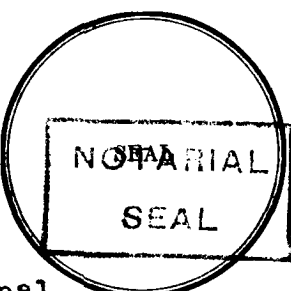
