THIS AGREEMENT made and entered into this 26th day of December 1944, by and between Leigh Brown and Edith Brown, husband and wife, of the County of Madison and State of Iowa, present owners of the premises described in the mortgage hereinafter mentioned, parties of the first part, and the Union State Bank, Winterset, Madison County, Iowa, party of the second part;

WITNESSETH: Whereas, Leigh Brown and Edith Brown, husband and wife, did execute and deliver unto the Union State Bank, Winterset, Iowa, a certain mortgage and note therein set forth, said note and mortgage bearing date the 1st day of March 1939, which mortgage was recorded in Mortgage Record 89, on page 238 of the records of the County Recorder of Madison County, Iowa, to secure the payment of said note of the full amount of Three Thousand (\$3000.00) Dollars and interest; and
