THIS INDENTURE, Made and entered this 1st day of March A. D. 19 46
by and between E. J. Patterson and Lela Patterson, husband and wife,
of the County of Madison and State of Iowa, party of the first part, Mortgagor,^s and
Nettie M. Purvis
of Madison County, Iowa, party of the second part, Mortgagee.

WITNESSETH: That the said party of the first part for and in consideration of the sum of
Four Thousand - - - - - (\$4000.00) DOLLARS
paid by the said party of the second part, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell and convey unto the said second party, its heirs, successors and assigns forever, the following described real estate, situated in the County of Madison and State of Iowa, to-wit:

The East Half ($\frac{1}{2}$) of the Northeast Quarter ($NE\frac{1}{4}$), and the North (N) Thirty (30) acres of the West Half ($W\frac{1}{2}$) of the Northeast Quarter ($NE\frac{1}{4}$), and the Northeast Quarter ($NE\frac{1}{4}$) of the Northwest Quarter ($NW\frac{1}{4}$), all in Section Twenty-Four (24), Township Seventy-Four (74) North, Range Twenty-Seven (27) West of the 5th P.M.,

with all appurtenances thereto belonging and also all the rents, issues, use and profits of said land, including all crops matured and unmatured grown upon said land and income therefrom, from the date of this instrument until the debt secured hereby shall be paid in full.

To have and to hold the premises above described with all the appurtenances thereto belonging and all estate, title, dower, right of homestead and claims whatsoever of said first party unto the said second party, its heirs, executors and assigns forever; the intention being to convey an absolute title in fee to said premises.
