HENDERSONS AUTOMOTIVE & IMPLEMENT

We, whose names are hereunto subscribed, associate ourselves into a body corporate under the provisions of Chapter 384, Code of Iows (1939), assuming all the powers, rights, and privileges granted bodies corporate and all the duties end obligations imposed by the lews o the State of Iqwa, and do hereby adopt the following Articles of Incorporation, to-wit:

ARTICLE I - Name and Flace of Business.

Section 1. The name of this corporation shall be "Hendersons Automotive & Implement", Section 2. The principal place of business of this corporation shall be in the City of Winterset, County of Madison, State of Iowa.

Section 3. This corporation may establish branch offices and agencies in Iowa, or in other States, as the Board of Directors may deem necessary or

ARTICLE II - Objects and Furposes

Section 1. The objects and purposes of this corporation shall be to carry on a general automobile agency and agricultural implement business, and in connection therewith,

- (a) To buy, sell and deal in any and all types and kinds of automobiles, trucks, tractors, trailers, airplanes, gliders and other passenger and commercial transporortation equipment, and all parts, supplies, accessories and appliances therefor,
- (b) To buy, sell end deal in any and all types and kinds of implements, machinery, tools, vehicles, and other articles pertaining to agriculture, and all parts, supplies, accessories and appliances therefor, and
- (c) to carry on and conduct a general garage and shop for the purpose of repairing, servicing and storing any and all of the foregoing items.

Section 2. In furtherance and not in limitation of the general powers conferred by the laws of the State of Iowa, and the purposes and objects hereinbefore stated, it is expressly provided that the corporation also shall have the following powers:

- (a) To acquire, deal with and dispose of, in any manner whatsoever, any and all kinds of real and personal property, including stock of the corporation.
- (b) To do everything necessary, proper, convenient or incidental to the accomplishment of the purposes and objects of the corporation or which is calculated, directly or indirectly, to promote the welfere or interests of the corporation or enhance the value or render profitable any of its property or rights.
- (c) In general, to carry on any business not contrary to the laws of the State of Iowa, and to do any and all of the acts and things hereinbefore or hereinafter set forth to the same extent as natural persons could do as principal, factor, agent, contractor, trustee or otherwise, either along or in company with any person or persons, entity, syndicate, pertner ship, association or corporation.

Section 8. The foregoing clauses are to be construed both as purposes and powers; and it is hereby expressly provided that the enumeration herein of specific purposes, objects and powers shall not be held to limit or restrict in any manner the general powers of the corporation. It is the intention that the purposes, objects and powers specified in each of the paragraphs of this Article II shall, except as otherwise expressly provided, in no wise be limited or restricted by the references to or inferences from the terms of any other clause or paragraph of this article or of any other article in these Articles of Incorporation.

ARTICLE III - Ceptiel Stock

Section 1. The authorized capital of this corporation is Fifty Thousand Dollars (\$50,000.00) to be divided into Five Hundred (500) shares of Common Stock of the par value of One Hundred Dollars (\$100.00) each.

Section 2. Capital stock shall be issued at such times and under such conditions as the Board of Directors may determine; provided, however, that no stock shall be issued until the corporation shall have received its full par value in cash or property, as provided by the laws of the State of Iowa; and when issued, all shares shall be fully paid and forever nonassessable.

Section 3. At all meetings of stockholders, each stockholder shall be entitled to one vote for each share of capital stock held by him, which may be east by the stockholder in person or by proxy

Section 4. The authorized capital stock of this corporation may be increased by the vote of sixty-six and two-thirds per cent (66 2/3%) in interest of all the stockholders, by the adoption of an amendment to these Articles. When the outstanding capital stock of this corporation is increased, the additional shares shall be offered to the existing stock-holders in proportion to their holdings of such stock, at not less than per value.

Section 5. The subscriptions for the ownership of all shares of the common stock of this corporation are subject to the condition that any holder of such shares desiring to sall the

some shall first give the corporation sixty (50) days, notice in writing of the proposed sale the number of shares proposed to be sold, the price at which the proposed sale is to be made, and the name of the prospective buyer; and during said ten days, the corporation shall have the sole option to buy the said shares or place them with the remaining stockholders at the price named.

ARTICLE IV - Commencement and Duration

Section 1. The corporate period of this corporation shall begin on the date of the Secretary of State issues a Certificate of Incorporation and shall terminate at the expiration of twenty (20) years from the date of issuence of the aforesaid Certificate, unless extended or renewed as provided by law or unless sooner dissolved by a vote of the majority of the outstanding shares of the capital stock, at an annual meeting or at a special meeting ealled for that purpose, or by unanimous consent as provided by law.

Section 2. Each and every holder of capital stock of this corporation covenants and agrees for himself, his heirs, executors, administrators, and assigns, that the corporate period of this corporation may be renewed from time to time, if a majority in interest of the holders of the capital stock wate in favor of such renewal at any regular meeting, or at any special meeting called for that purpose, without any obligation or liability on the part of the corporation, or those voting for such renewal, to purchase any capital stock voted against such renewal; and the issuence or transfer of stock of this corporation shall, by virtue of this Article, and without more, he subject to such right or renewal.

ARTICLE V - Directors and Officers

Section 1. The affairs of this corporation shall be conducted by a Board of Directors consisting of not less than three nor more than seven members, who shall be elected by the stockholders at their annual meeting to be held on the third Tuesday in December of each year. Directors are not required to be stockholders in this corporation.

Section 2. The Board of Directors may fill all vacancies occurring in its membership between annual elections by appointments of persons to hold office for the remainder of the ter Section 3. Until the first regular meeting of the stockholders, the directors of the
