ARTICLE I. NAME

The name of this body is Earlhom Monthly Meeting of Friends Church by which name it shall acquire and hold property, real, personal, and mixed, are and be sued; defend and be defended, and adopt a Common Seel, and alter the same at pleasure.

ARTICLE II. MEETING

The regular business meetings of this body shall be held at Earlham, Iowa, the third Seventh Day of each month at two o'clock P.M., and at such other times as said body in regular session assembled shell direct.

ARTICLE III. MEMBERSHIP

The members of this body shall consist of the persons whose names appear upon the Membership list of Earlham Monthly Meeting of Friends Church of Earlham, Madison County, Iowa, an unincorporated body which by these presents merges into Earlham Monthly Meeting of Friends Church, a corporation as therein described, together with such persons as may be received into membership from time to time under the rules prescribed in the discipline of lowa Yearly Meeting of Friends Church.
