#### ARTICLES OF INCORPORATION

The Undersigned, L. O. Petten, Ralph Erb and Phillip Duff of Earlhem, Madison County, Iows, for the purpose of forming a non-profit Corporation, pursuent to the provisions of the Statutes of the State of Iows, and more particularly under Chapter 504, Code of Iowa, 1946, do hereby adopt the following Articles of Incorporation:-

### PARAGRAPH I.

The name of this Corporation shall be THE EARLHAM TENNIS AND SKATING CLUB. The principal place for the transaction of its business shall be Earlham, Madison County, Iowa,

# PARAGRAPH II.

The purpose of the organization shall be to establish, maintain, supervise and provide for a community recreational center and playground, for the benefit and welfare of the general public in and about the community of Earlham, Iowa, and to this end this Corporation shall have the power to receive, hold, enjoy and disburse all property and money of every kind and nature donated, bequeathed, devised, conveyed or transferred to it, said funds to be disbursed only upon the express approval of the Board of Trustees, and for the purposes only of said recreational center and playground.

# PARAGRAPH III.

The membership of this corporation shall consist of the members of the Board of Trustees and their successors in office, and such other individuels as may be elected to membership b the Board of Trustees.

# PARAGRAPH IV.

There shell be no capital stock in this Corporation, nor shall any of its funds or property, real or personal, be donated to any individual person, or to any corporation or essociation organized for pecuniary profits.

## PARAGRAPH V.

The menagement of this Corporation shall be vested in a Board of Trustees consisting of Three (5) members, whose term shall be one, two and three years respectively, and who shall be elected by the members of the Corporation at the annual meeting, in the manner to be determined by the Board of Trustees, and that L. O. Patten, Ralph Erb and Phillip Duff of Earlham,

Madison County, Iowa, shall serve as such Trustees until the first annual meeting of this corporation.

PARAGRAPH VI.

All vacancies on the Board of Trustees shall be filled by the remaining members of the Board of Trustees until the next annual meeting, when a member shall be elected to fill the unexpired term of the person ceasing to be a member, said election to be in the menner to be provided for by the Board of Trustees.

## PARAGRAPH VIII.

The officers of this organization shall consist of a Chairman, Vice-Chairman, a general Secretary and a Treasurer, all of whom shall be elected by the Board of Trustees, the time, manner and method of holding such election shall be determined by the Board of Trustees.

PARAGRAPH IX.

The Board of Trustees shall have the power to make and alter By-Laws at their pleasure.

PARAGRAPH X.

The private property of the members of this Corporation shall in no event be liable for the debts of the Corporation.

PARAGRAPH XI.

The Corporation shall not have a Corporate seal.

PARAGRAPH XII.

This Corporation shall commence and be in existence from the date of the filing of these Articles of Incorporation in the manner provided by Statute, and shall continue its corporate existence for a period of Twenty (20) years, unless sooner disselved by a majority vote of the members of the Board of Trustees of this organization.
