Everitt who is named as one of the purchasers in a written contract under date of September 18, 1944 recorded in Deed Record 80 at page 584 on October 6, 1945, in the office of the County Recorder of Madison County, Iowa wherein Mary Farris, single, as Seller agreed to convey to G.C. Everitt and wife Ethel and this affiant, C.C. Everitt and wife Madaline Everitt as Purchasers, the following described real estate, to wit:

I further state that I am the one and same identical person who is listed as one of the heirs of the Estate of Guy Chester Everitt who was my natural father and who died intestate at Des Moines, Iowa on January 18, 1945 whose estate was administered in the Probate Division of the District Court of Iowa in and for Polk County and designated as the Estate of Guy Chester Everitt, Deceased, Probate No. 30784 Docket 101, a transcript of said Probate Proceedings was filed in the office of the Clerk of the District Gourt of Medison County, Iowa on June 28, 1945 in Probate Docker "L" at page 205 and designated as Number 4860 Probate, in which the name of this efficient is listed as Curtis G. Everitt.

I further state the G.C. Everitt and Guy Chester Everitt, who was the natural father of this afficient and who died intestate in Des Moines, Iowa on January 18, 1945, is the one and same identical person named in the contracts for the sale of the real estate above described which contracts are recorded in the office of the Recorder of Madison County, Iowa in Deed Record 80 at pages 584 and 595, respectively, and as more particularly set out heretofore in this affidavit.
