and say that I am the natural daughter of A.M. Ferris who was my natural father. I state that my father, A.M.Farris, died intestate in Medison County, Iowe on the 17th day of April 1938, leaving no surviving spouse, his wife, Eve Farris, who was my mother, predeceased her husband, A.M.Farris, and died intestate on the 24th day of March, 1911 and after the death of Eva Farris, my father, A.M.Farris, remained single and never married again.

This affiant states that in the contract of sale entered into between her and the Everitts as above described and appearing of record in Deed Record 80 at page 584 in Madison County, Iowa, one tract of said real estate is erroneously described in that contract as "and the W. 32 Acres of the SEI, SEI of Sec. 36-76-27".

I state that it was intended by all parties to that contract that the said tract of the real estate intended to be conveyed by the Seller to the Purchasers and that was conveyed should have been described as follows:

"The West Three-fourths (1) of the Southeast Quarter (1) of the Southeast Querter (1), the East one-fourth (1) of the Southeast Quarter (1) of the Southeast Quarter (1) except the South 64 rods thereof, Section 36, Township 76-North, Range 27, West of the 5th P.M., Medison County, Iowa, containing 32 acres, together with the other real estate described in said contract.
