FIRST MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, that: (1) THE MARINE MIDLAND TRUST COMPANY OF NEW YORK, a corporation of the State of New York, is Successor Trustee under that certain indenture of mortgage and deed of trust executed by the St. Paul and Kansas City Short Line Railroad Company, a corporation of the State of Iowa, to Bankers Trust Company, as Trustee, dated February 23, 1911, as supplemented and amended by Supplemental Indentures dated October 23, 1911, September 17, 1913, October 16, 1913, March 16, 1914, November 26, 1924 and March 19, 1932 (hereinafter referred to as the "First Mortgage"), under which there have been issued St. Paul and Kansas City Short Line Railroad Company First Mortgage Gold Bonds, due February 1. 1941, in the aggregate principal amount of \$22,828,500 and £1,000,000, of which \$9,391,500

\$18,155,500 and £56,300 in principal amount are outstanding.

- (2) A Plan of Reorganization of The Chicago, Rock Island and Pacific Railway Company and certain of its subsidiaries has been confirmed by the District Court of the United States for the Northern District of Illinois, Eastern Division, in proceedings for the reorganization of a railroad under Section 77 of the Bankruptcy Act, entitled "In the Matter of The Chicago, Rock Island and Pacific Railway Company, Debtor, No. 53209," in which proceedings St. Paul and Kansas City Short Line Railroad Company is a subsidiary debtor.
- (3) Said District Court of the United States for the Northern District of Illinois, Eastern Division, by the consummation order and final decree entered in said reorganization proceedings, vested title to all of the property of said subsidiary debtor in Chicago, Rock Island and Pacific Railroad Company, a corporation of the State of Delaware, the reorganized company incorporated pursuant to said Plan of Reorganization, and declared the First Mortgage to be null and void and the lien thereof cancelled and released, as of 12:01 A. M., Central Standard Time, on January 1, 1948, and ordered and directed the undersigned, The Marine Midland Trust Company of New York, as such Successor Trustee, in confirmation thereof, to execute and deliver this instrument of satisfaction and release.

WHEREFORE, in consideration of and compliance with the orders and directions of the Court in said reorganization proceedings, the undersigned, The Marine Midland Trust Company of New York as such Successor Trustee, does hereby: (1) remise, release, convey and quitclaim unto Chicago, Rock Island and Pacific Railroad Company, a corporation of the State of Delaware, the above mentioned reorganized company, and its successors and assigns, all estate, right, title, interest, claim and demand whatsoever which it may have acquired under and by virtue of or arising from the First Mortgage in and to all property of every kind or character whatsoever and wheresoever situated, real, personal or mixed, conveyed or intended to be conveyed by the First Mortgage, all to the same effect as if herein fully set forth; (2) acknowledge full satisfaction and discharge of the First Mortgage and full discharge of all rights, claims and demands which it, as such Successor Trustee, may have acquaired by virtue of the First Mortgage; and (3) consent and direct that the lien of the First Mortgage be discharged of record, both as a real estate mortgage and as a chattel mortgage, and authorize the recording officer of each county and state in which the First Mortgage has been recorded or filed to discharge the same of record in his office.


