NOTICE OF TERMINATION

THIS NOTICE OF TERMINATION (this "Notice") is made this 17 day of March, 2020 by Invenergy Wind Development LLC, a Delaware limited liability company with its principal place of business at One South Wacker Drive, Suite 1800, Chicago, Illinois 60606 ("Grantee").

WHEREAS, Grantee and James M. Cassady, Brian P. Cassady and Cindi M. Cassady Trustees of the James and Sharon Cassady Irrevocable Trust dated August 31, 2012 (collectively, "Owner") entered into that certain Agreement Regarding Easements dated October 10, 2018, as evidenced by that certain Memorandum of Agreement Regarding Easements of even date recorded November 16, 2018 in Book 2018, Page 3744, in the official public records of Madison County, Iowa, which Agreement encumbers that certain real property described on Exhibit A attached hereto and incorporated herein by this reference; and


