Interment Space(s): **Spaces 1, 2, 3, 4, Lot 215, 1962 Addition**

**Certificate of Interment Right and
Interment Rights Purchase Agreement**

This certifies that **The Winterset Cemetery Improvement Association** has transferred and conveyed to: **D. R. Lillard** ("Purchaser, heirs and assigns") the interment space(s) described above in **The Winterset Cemetery** for the total price of **Four Hundred Dollars (\$400.00)** with the following terms and conditions:

1. The interment space(s) is/are to be used for interment purposes only and the Purchaser's rights are limited by and subject to The Winterset Cemetery's rules and regulations as now exist or as amended in the future.
2. This Certificate of Interment Rights conveys only a right to be interred in the interment spaces(s) and in no way is any real estate title conveyed to the Purchaser. Furthermore, only one interment will be permitted in each interment space unless specifically authorized by The Winterset Cemetery Improvement Association.
3. Services related to interment in the interment space(s) are not included in the rights conveyed and are subject to The Winterset Cemetery's service charges and availability. These charges will be determined at the time they are purchased and are subject to change.
4. The Cemetery must receive the following information prior to any interment. The notice must include the name of the deceased, the deceased's birth date, the deceased's date of death, next-of-kin, funeral establishment (if any) and any other required information.
5. Purchaser shall not have the right to sell the interment space(s). If Purchaser desires to sell the interment space(s), The Winterset Cemetery shall repurchase such interment space(s) for the price paid by Purchaser to The Winterset Cemetery less the 20% which was paid to The Winterset Cemetery's Perpetual Care Fund. Purchaser may transfer ownership without consideration, but any transfer of ownership by will or otherwise will be recognized by The Winterset Cemetery only after it is recorded with The Winterset Cemetery and a new Certificate of Interment Rights is issued to the new owner.
6. The Winterset Cemetery shall use the Purchaser's address for any official notices concerning the interment space(s). The Purchaser shall notify The Winterset Cemetery of any change in their address.
7. The terms and conditions described herein are binding upon the Purchaser's heirs, successors, and assigns and enforceable only by The Winterset Cemetery.
8. The Winterset Cemetery shall set aside and deposit in the Perpetual Care Fund an amount equal to or greater than fifty dollars or twenty percent (20%) **(\$80.00)** of the gross selling price received for each sale of interment rights, whichever is more. Perpetual Care Fund deposits will be made within ten days after receipt of payment. The Perpetual Care Fund is an irrevocable trust; deposits cannot be withdrawn even in the event of cancellation, and the trust's income shall be used by the cemetery for its care.
9. This is not a multi-item contract.
10. The Winterset Cemetery will only sell developed interment space(s) in the agreement.
11. There is no right of substitution to substitute the above described interment space(s) for another interment space(s) in The Winterset Cemetery.
12. This Agreement is irrevocable and there is no right to cancel.
