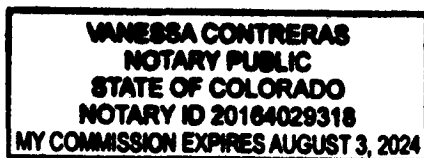
STATE OF IOWA, COUNTY OF POLK, ss:
