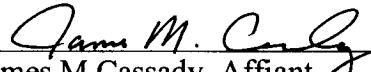

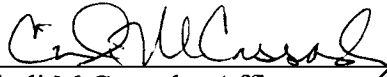

We, James M Cassady, Brian P Cassady and Cindi M Cassady, being first duly sworn (or affirmed) under oath, state of our personal knowledge that:

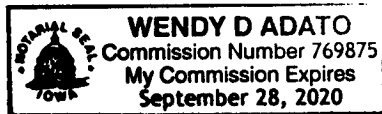

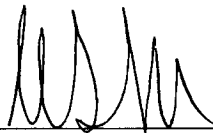
