The Southwest Quarter (¼) of Section One (1), Township Seventy-six (76) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, EXCEPT the following-described tracts, to-wit:

1. That part of Parcel "H" located therein, as shown in Plat of Survey filed in Book 2010, Page 2840 on November 10, 2010 in the Office of the Recorder of Madison County, Iowa;
 2. Parcel "G" located in the Southeast Quarter (¼) of the Southwest Quarter (¼) of said Section One (1), containing 3.12 acres, as shown in Plat of Survey filed in Book 2009, Page 766 on March 17, 2009 in the Office of the Recorder of Madison County, Iowa;
