AFFIDAVIT OF SURVIVING SPOUSE FOR CHANGE OF TITLE TO REAL ESTATE

STATE OF IOWA, COUNTY OF WARREN, ss:

- I, Marilyn A. Pottorff, being first duly sworn on oath, depose and state as follows:
- 1. I, Marilyn A. Pottorff ("affiant"), am the surviving spouse of <u>Joel Irwin Pottorff</u>, who died on <u>February 20, 2022</u>.
- 2. The affiant submits that the following described real estate was owned only by Joel Irwin Pottorff and this Affiant, as joint tenants with rights of survivorship, as "husband and wife," by operation of Iowa Code § 557.15, at the time of Joel Irwin Pottorff's death:

- 7. An Iowa inheritance tax return is not required to be filed pursuant to Iowa Code Section 450.22 subsection 3.
