LEGAL DESCRIPTION

The Southeast Quarter ($\frac{1}{4}$) of the Northwest Quarter ($\frac{1}{4}$) and the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of Section Twenty-three (23), Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa; **EXCEPT** a tract of land located in the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of said Section Twenty-three (23), containing 13.76 acres, as shown in Plat of Survey filed in Book 2, Page 61 on February 13, 1987 in the Office of the Recorder of Madison County, Iowa; **AND EXCEPT** the St. Charles Cemetery located in the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of said Section Twenty-three (23), and more particularly described as follows, to-wit: Commencing at a point 51 Rods and 6.06 feet North of the Southwest corner of the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of said Section Twenty-three (23), thence East 981.50 feet, thence continuing East along an Eastward extension of the North line of said cemetery to a point on the East line of the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of said Section Twenty-three (23), thence South to a point 410.29 feet North of the Southeast corner of the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of said Section Twenty-three (23), thence South $89^{\circ}56'00''$ West 1295.80 feet to a point on the West line of the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of said Section Twenty-three (23) located 515.97 feet North of the Southwest corner of the Northeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of said Section Twenty-three (23), thence North approximately 331.59 feet to the Point of Beginning.
