## EASEMENT AGREEMENT

Charles R. Strawn and Audrey J. Strawn, husband and wife, hereinafter called "Grantors", for valuable consideration, do hereby grant to Kevin D. Reynolds and Kimberly K. Reynolds, husband and wife, hereinafter called "Grantees", a perpetual Ingress-Egress Easement upon the following-described real estate:

> The South Sixty (60) feet of Parcel "P" in the Southeast Quarter of the Southeast Quarter (SE1/4 SE1/4) of Section 14, Township 75 North, Range 26 West of the 5th P.M., Madison County, Iowa, as shown in Plat of Survey filed February 25, 2022, in Book 2022, Page 569 of the Recorder's Office of Madison County, Iowa.

Said Easement shall benefit the following described property:

Grantors agree to grant the Grantees an easement for ingress and egress to the property, including the right to use the easement area to bring any and all utility services to the benefitted property. Grantees and Grantors agree that the expense of maintenance of the easement shall be borne exclusively by the Grantees. Grantors covenant that no act will be permitted within the easement area which is inconsistent with the rights hereby granted.

In all other respects the Grantors shall be able to use said easement area as they normally would. This Easement shall run with the land and be binding upon successors in interest.
