## TRUSTEE WARRANTY DEED

For the consideration of One (\$1.00) Dollar(s) and other valuable consideration, Alan R. Algreen, Trustee under the Sheila M. Algreen Living Trust, dated May 9, 2018, does hereby convey to Julie R. Plant, the following described real estate:

Lots Twenty-four (24) and Twenty-five (25) of Honor's Acres Second Addition to the Town of Winterset, Madison County, Iowa.

Subject to all covenants, restrictions and easements of record.

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.
