#### AMENDMENT OF RIGHT-OF-WAY AGREEMENT

#### WITNESSETH

WHEREAS, Natural Gas Pipeline Company of America LLC, its successors and assigns (hereinafter referred to as "NGPL"), is the owner and holder of certain rights-of-way and easements granted pursuant the following instruments: (i) that certain Right-of-Way Agreement executed by Henry Pope, Herman Pope and Dessie Pope, husband and wife on October 3, 1930 and recorded October 22, 1930 in Book 70 Page 68 in the Office of the Recorder of Madison County Iowa, granted, conveyed and warranted to Continental Construction Corporation, its successors and assigns an Option to construct, test, reconstruct, renew, operate, maintain, inspect, alter, repair and remove a pipeline or pipelines for transportation of gas, oil, petroleum, or any of its products, water or other substances, and such drips, valves, fittings, meters and other equipment and appurtenances as may be necessary or convenient for such operations over and through the described real estate in Madison County, Iowa "Original Right-of-Way Agreement".

WHEREAS, NGPL has succeeded to all the property, right, title and interest of the Continental Construction Corporation and to the above referenced Right of Way Agreement.

WHEREAS, the rights-of-way and easements granted pursuant to the Easement Agreements encumber the property owned by Alvin D. and Carolyn M. Borntrager of 3113 Larkspur Avenue, Lorimor, IA 50149("Landowner") described on Exhibit A attached hereto (the "Landowner Property").

WHEREAS, at the request of the Landowner, NGPL is willing to amend the Right-of-Way Agreement

**NOW, THEREFORE,** for valuable consideration, the receipt of sufficiency of which is hereby acknowledged, NGPL and Landowner hereby agree as follows:

- NGPL specifically reserves and retains all rights-of-way, easements, rights, benefits, title and interest granted under the Right-of-Way Agreement in and to the Landowner Property described in Exhibit A attached hereto.
- 2. Landowner hereby grants an exclusive, defined pipeline easement to NGPL which prohibits the establishment of any enterprise or activity within 660 feet of the NGPL Amarillo #1, NGPL Amarillo #2 and NGPL Amarillo #3 pipelines that would involve the occupancy of 20 or more people, 50 days or more per any 12-month period, including for example, but not limited to a school, recreational facility, farmers market with public parking, business enterprise that includes parking.
- 4. To the extent that the Grantor wishes to develop the land within the defined Right of Way, Grantee reserves the right to review and edit, at Grantee's own discretion, any plans prior to initiation of any construction or establishment of said plan, the approval of which shall not be unreasonably withheld.
- 5. NGPL, in exercising its rights under the Easement Agreements, will comply with all applicable statutes, ordinances, rules, and regulations of all governing public authorities as those statutes, ordinances, rules, and regulations are amended from time to time, and obtain at its sole cost and expense any permits, approvals, or consents reasonably required in connection with exercising its rights under the Easement Agreements.
- 6. Except as specifically amended hereby, all terms and conditions of the Original Right-of-Way Agreement, referenced in the beginning of this Amendment remain in full force and effect.
