TRUSTEE WARRANTY DEED

KNOW ALL PERSONS BY THIS DEED: That **Bradley W. Sweeney and Quendy S. Sweeney, Trustees of the Bradley W. Sweeney Living Trust dated October 14, 2015** (the "Grantor"), do hereby Convey to **Julie Egli and Travis Egli**, a married couple (the "Grantees"), as joint tenants with full rights of survivorship and not as tenants in common, the following-described real estate:

Lot Seven (7) of SWEENEY ACRES SUBDIVISION, located in the North Half (½) of the Northwest Quarter (¼) of Section Two (2), Township Seventy-four (74) North, Range Twenty-six (26) West of the 5th PM, Madison County, Iowa.

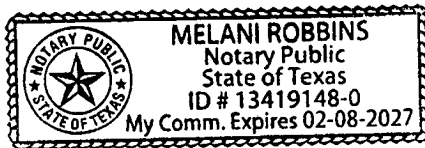
