The East 112 feet and 10 inches of Lot Four (4) in Burger's Four Acre Lot in the City of Winterset, Madison County, Iowa.

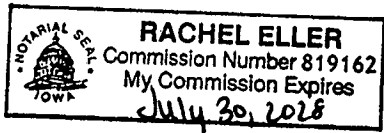
