We, Jane A. Otton, Mary L. Beavers, a/k/a Mary K. Beavers, and Margaret H. Shearer being first duly sworn and under oath depose and state as follows:

1. We are well and truly acquainted with the title to the real estate legally described as:

Northeast Quarter (NE¼) of the Southeast Quarter (SE¼) of Section Five (5), Township Seventy-six (76) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa.

- 2. Carita A. Kelleher owned and held title to the above-described real estate.
