


EAST 1/4 - NO RECORD OF MONUMENT WAS FOUND IN THE COUNTY RECORDER'S OFFICE OR THE COUNTY ENGINEER'S OFFICE. A PLAT OF SURVEY IN SECTION 16 AND LOCATED IN THE RECORDER'S BOOK 2006 PAGE 202 REFERENCED A FOUND 5/8" IRON BAR AT THE WEST 1/4 OF SECTION 16 BUT NO BEARING OR DISTANCE ON THE LINE TYING IT TO THE SURVEY. ANOTHER PLAT OF SURVEY IN SECTION 16 AND LOCATED IN THE RECORDER'S BOOK 3 PAGE 421 CALLED OUT FENCE CORNER LOCATIONS BUT DISTANCES DO NOT MATCH ANY ADJACENT MONUMENTS OR FENCE LINES. WENT TO THE FENCE LINE INTERSECTION AT THE EAST 1/4 CORNER OF SECTION 17 AND DUG BETWEEN 2 CORNER POSTS TRYING TO FIND THE 5/8" IRON BAR CALLED FOR IN THE PREVIOUS SURVEY. FOUND A 9"x9" STONE, 1.3' BELOW THE DIRT SURFACE IN BETWEEN THE 2 CORNER POSTS. DID NOT FIND THE 5/8" IRON BAR FROM THE PREVIOUS SURVEY. THE FOUND STONE MATCHES WELL WITH G.L.O. DISTANCES TO SURROUNDING SECTION CORNERS AND FITS WELL WITH ANCIENT FENCE LINES RUNNING EAST, WEST, AND NORTH. ACCEPTED THE 9"x9" STONE AND HELD THE HIGHEST POINT FOR LOCATION. SET A 5/8" REBAR ON NORTH SIDE OF STONE FOR DETECTION PURPOSES ONLY. SET 3 NEW TIES.
