Tobis, Co-Trustees of the Tobis Living Trust dated December 2, 2025, as all our right, title, interest, estate, claim and demand in the following described real estate in Madison County, Iowa:

A tract of land described as follows, to wit: Commencing at a point 68 rods North of the Southeast Corner of the Northwest Quarter (1/4) of Section Twenty-nine (29), in Township Seventy-four (74) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, and running thence South to the Southeast Corner of said Northwest Quarter (1/4) thence West to the Southwest Corner of said Northwest Quarter (1/4), thence North 52 rods, thence in a Northeasterly direction to the place of beginning.
