SPECIAL WARRANTY DEED

This Indenture, made on the 20 day of March, 2025 by and between the Secretary of Veterans Affairs, an Officer of the United States of America, whose address is Department of Veterans Affairs, 810 Vermont Ave. N.W., Washington, DC 20420, hereinafter referred to as GRANTOR, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration received from Carolyn Zacker and Christopher Zacker, a married couple, as joint tenants with full rights of survivorship, hereinafter referred to as GRANTEE, GRANTOR conveys to GRANTEE the following described real estate:

LOT FIVE (5) OF GLENWOOD PLAT 1, AN ADDITION TO THE CITY OF WINTERSET, MADISON COUNTY, IOWA.

COMMONLY KNOWN AS 815 N 11TH AVENUE CIR., WINTERSET, IA 50273.

GRANTOR covenants with GRANTEES that GRANTOR:

- 1) is lawfully seized of such real estate and that it is free from encumbrances, except easements, reservations, covenants and restrictions of record;
- 2) has legal power and lawful authority to convey the same; and
- 3) warrants and will defend title to the real estate against the lawful claims of all persons claiming the same or any part thereof through, by or under Grantor.

There is no known private burial site, well, disposal site for solid waste, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.

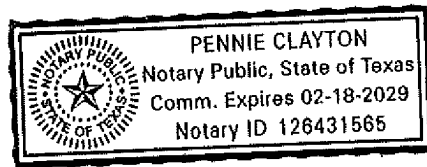
