TOT Inspection Report Overall Narrative Comments: All wastewater goes to septic. 1250 gallon watertight concrete septic tank in working condition with slight deterioration. Buried with 1.5ft of dirt cover. Exposed center and outlet pancake lid. Inlet and outlet baffles present, no outlet effluent filter. Outlet pipe is slightly distorted, pointed downward. This is not affecting flow. Plastic distribution box is cracked on the side near inlet indicating the dbox is not watertight. Would recommend replacing dbox. Baffle and speed levelers present. Hydraulic load tested(via house) 5x75 equaling 375ft of rock and pipe laterals with 200 gallons. Each lateral took water and probed dry and clean. All recommendations are subject to county's approval.

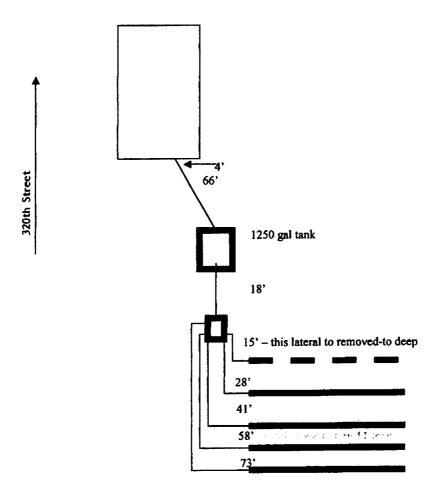
