


That part of the Northeast Quarter of the Northeast Quarter of Section 10, Township 75 North, Range 26 West of the 5th P.M., Madison County, Iowa, described as follows; Beginning at the Northeast corner of said Section 10; thence South 86 degrees 17 minutes 54 seconds West, 1310.42 feet along the North line of said Northeast Quarter of the Northeast Quarter to the Centerline of an existing County road and also the Northeast corner of a tract of land shown on a Plat of Survey recorded in Farm Plat Book 2 Page 150; thence South 29 degrees 01 minutes 50 seconds East, 792.14 feet along said Centerline and to a corner of said tract of land; thence South 75 degrees 32 minutes 59 seconds East, 216.40 feet along said Centerline and to a corner of said tract of land; thence South 79 degrees 35 minutes 22 seconds East, 295.70 feet along said Centerline; thence South 87 degrees 11 minutes 13 seconds East, 236.14 feet along said Centerline; thence North 82 degrees 25 minutes 25 seconds East, 194.64 feet along said Centerline to the East line of said Northeast Quarter of the Northeast Quarter; thence North 00 degrees 23 minutes 18 seconds West, 870.60 feet to the Point of Beginning, having an area of 20.80 Acres including 1.56 Acres of Road Easement.

ORIGINAL LEGAL DESCRIPTION:
