QUITCLAIM DEED

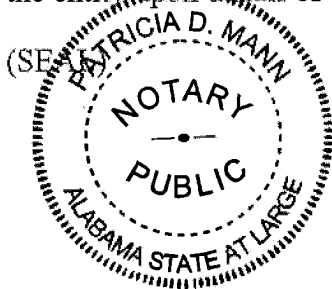
