I, Lacey Forsyth, being first duly sworn on oath state:

1. This Affidavit concerns the following described property:

The Southeast Quarter of the Southwest Quarter of Section 18, Township 75 North, Range 27 West of the 5<sup>th</sup> P.M., Madison County, Iowa.

- I am the daughter of Gary Christensen, who granted two easements to Farmers Electric Cooperative, Inc. The first easement was dated and filed July 11, 2008, in Book 2008, Page 2195 of the Recorder's Office of Madison County, Iowa. The second easement was dated and filed July 11, 2008, in Book 2008, Page 2196 of the Recorder's Office of Madison County, Iowa.
- 3. I can state of my own personal knowledge, that at the time of these easements,
  Gary Christensen was the owner of the following described real estate:

I give this Affidavit to clear any clout of title that may be on the Southeast Quarter of the Southwest Quarter of Section 18, Township 75 North, Range 27 West of the 5<sup>th</sup> P.M., Madison County, Iowa, except Parcel "F" as shown in the Plat of Survey filed April 3, 2008, in Book 2008, Page 1072 of the Recorder's Office of Madison County, Iowa.
