"C" ORDER TO REBUILD PARTITION FENCE. State of Iowa, Madison County, Crawford Township, ss: WHEREAS, on the 17th day of June A.D. 1925, M. M. Gavin made complaint in writing to us, the fence viewers of said township, that John Linnan refused and neglected to repair or rebuild his portion of the partition fence on the land between their premises, to-wit: Commencing at a point on the east bank of Middle River, 4 rods East of the Southwest Corner of the Northwest Quarter (NW1) of the Southeast Fractional Quarter (SE Frl 1) Section Twenty-five (25) Township Seventy-six (76) North, Range Twenty-six (26), running thence East to the Southeast Corner of said 40 acre tract, thence North to Middle River as it flows East 'across the East line of said 40-acre tract, and we hereby certify that on the 17th day of June A.D. 1925, we caused notice in writing to be served on the said John Linnan, that on the 24th day of June A.D. 1925, at 9 o'clock A.M., we would meet at said line and consider the matter of the said complaint and make such order as might be right in the premises; and now, having met at the time and place named in said notice and having examined said partition fence and having heardthe arguments of the said parties, who were both present we find that said parties have already built a part of said partition fence. That John Linnan built 19 rods as follows: Commencing at a point on the East bank of Middle River, about 4 rods East of the South-

west Corner of the Northwest Quarter (2) of the Southeast Fractional Quarter (2), Section Twenty-five (25), Crawford Township, minning thence East 19 rods; that M. M. Gavin built the 36 rods East of the said 19 rods, running East to the West Bank of Middle River, as it turns and flows North across said line.
