AGREEMENT ON DIVISION OF PARTITION FENCE.

THIS AGREEMENT, made and entered into this 25th day of September, A. D. 1929, by and between E. E. McCall, of Winterset, Iowa, and Enoch Strable, of Bevington, Iowa, as to the partition fence running North and South between the following described land now owned by said abutting property owners:

The Southwest Fractional Quarter of the Southeast Quarter of Section Thirty-six (36), in Township Seventy-six (76) North, of Range Twenty-six, and the Northwest Fractional Quarter of the Northeast Quarter of Section (1), in Township Seventy-five (75) North, of Range Twenty-six (26), all West of the 5th P. M., is owned by said E. E. McCall;

and the Southeast Fractional Quarter of the Southeast Quarter of Section Thirty-six (36), in Township Seventy-six (76) North, of Range Twenty-six (26), and the Northeast Fractional Quarter of the Northeast Quarter of Section One (1), in Township Seventy-five (75) North, of Range Twenty-six (26), all West of the 5th P. M., is owned by said Enoch Strable.
