Whereas, on the 22nd day of May, 1935 W.A.Tincher made complaint to the undersigned Trustees in and for South Township, Madison County, Iowa, acting as the fence viewers of said Township, that Mrs. Lena Powers refused to build or pay for the building of her portion of the partition line fence on the land between the farm owned by the said W.A.Tincher and land owned by the said Mrs Lena Powers, all located in the southwest quarter of section twelve (12) Township 75 N., Range 26 N., of 5th P.M.

Whereas, we hereby certify that on the 23rd day of May, 1935, we gave proper notice to the said Mrs Lena Powers that the undersigned fence viewers would meet for the purpose of determining the controversity on the 31st day of May, 1935, at 9 o'clock, A.M. at the said partition fence.

The undersigned Fence-viewers having met at the time and place and the said W.A.Tincher and Mrs . Lena Powers being present.

The undersigned fence-viewers having heard both parties and examined said partition fence finds and it is hereby ordered:

That the east one half of the fence be given to Mrs Lena Powers to maintain and the west one-half be given to W.A.Tincher.
