Know all Men by these presents: That Whereas, in an action of Partition in the District Court of Madison County, Iowa, wherein Sarah E. Ford, et al were plaintiffs and Stella Jones et al were defendants, it was, on the 2nd day of May 1917, in pursuance of law ordered and decreed by said Court that the real estate hereinafter described be sold on the following terms, to-wit: at private sale for cash.

And Whereas, the undersigned, P.G. Rollstin, was then by said Court duly appointed referee to make such sale;

And Whereas; in pursuance of such order and decree, said real estate was duly appraised;

And Whereas, the said referee, did on the 3d day of May 1918 sell at private sale for cash, the real estate in said decree and hereinafter described, in conformity with the law and the decree of said Court, to Stella Jones for the sum of Twelve Hundred Dollars, she being the highest and best bidder therefor;

And Whereas, the said Stella Jones has complied with the terms of said sale, and of her bid, and has paid the sum of money so bid as aforesaid;

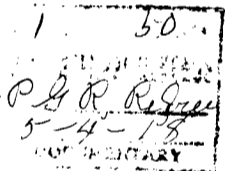
And Whereas, the said Court, on the 4th day of May 1918, approved and confirmed said sale;

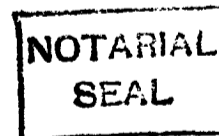
