



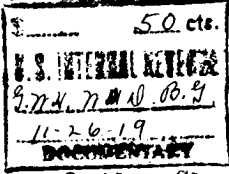

THIS INDENTURE, Made and executed this 26 day of November A.D.1919, by and be-
 tween The Christian Church of Patterson, Iowa of Patterson County of Madison and
 State of Iowa, of the first part, and M. Fort of Patterson County of Madison and State
 of Iowa of the second part. WITNESSETH: That the said party of the first part, for
 and in consideration of the sum of Three hundred Dollars, the receipt whereof is
 hereby acknowledged has bargained, and sold, and by these presents do grant, bargain, sell
 and forever QUIT CLAIM unto the said party of the second part, his heirs, executors
 and assigns, all their interest, claim or demand in and to the following described
 real estate, situated in the County of Madison and State of Iowa, to-wit:

The East Part of Lot Three (3) in Block Eleven (11) described as follows.

"Commencing at the North East Corner of said lot, thence South to the South
 east corner, thence west Six (6) feet thence North Sixty Six (66) feet, Thence
 West Eight (8) feet, thence North Sixty Six (66) feet Thence east fourteen
 (14) feet to place of beginning "



in the Original Town of Patterson.

This Deed is granted on authority of the Congregation of the Christian Church of Patterson, Iowa, November 25th, 1919.
