Townsend and Jennie L. Canning of Polk County, Iowa, and Ada M. Callison of Madison County, Iowa, and Dee Evelyn Cason of Greene County, Ohio, and Bessie M. Campbell of Gilliam County, Oregon, do hereby QUIT CLAIM unto the said Edwin L. Townsend, Jennie L. Canning, Ada M. Callison, Dee Evelyn Cason and Bessie M. Campbell, all my right title and interest in and to the following described premises situated in Madison County, and State of Iowa, to-wit:-

Lots Fifty-three (53) and Fifty-four (54) in the Original Town of Macksburg, Iowa, and a tract of land described as follows, to-wit:- Commencing at a point Thirty (30) rods West of the Northeast corner of Section Sixteen (16) in Township Seventy-four (74) North, of Range Twenty-nine (29) West of the 5th P.M. and running thence West Thirty-nine (39) feet, thence South Two Hundred Forty-seven and One-half (247½) feet, thence East Thirty-nine (39) feet, thence North Two Hundred Forty-seven and One-half (247½) feet to the place of beginning, and also a tract described as follows, to-wit:-
