This deed is given in lieu of a deed given to Charles Herren by E. G. Barker in the year 1914, and said deed was lost before being recorded.

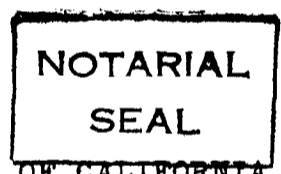
And the said .....hereby relinquishes her right of dower in and to the above described premises.

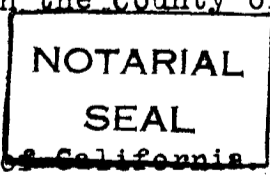
