WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That Seventh Day Adventist Society, of Winterset, Iowa, of Madison County and State of Iowa in consideration of the sum of One Dollar and other valuable consideration Dollars, in hand paid by The Iowa Seventh Day Adventist Association, a corporation, now of Nevada, of Story County and State of Iowa do hereby SELL AND CONVEY unto the said The Iowa Seventh Day Adventist Association, a corporation, and to its successors and assigns the following described premises, situated in the County of Madison and State of Iowa, to-wit:

Lot numbered Eight (8) in Block numbered Two (2), of Pitzer's Addition to Winterset, Iowa.

The intent and purpose of this instrument is to transfer and convey all title acquired under a deed dated Dec. 26th., 1881, to A. J. Stiffler, Mitchell Robinson and John M. Brown, Trustees of the Seventh Day Adventist Society, of Winterset, Iowa, the grantor in this conveyance being identical with the grantee in said former conveyance, which is recorded at page 148, of Town Lot Deed Record 5, of the Deed Records of Madison County.

This deed is made in pursuance of a resolution passed at a regular business meeting of the Seventh Day Adventist Society, of Winterset, Iowa, authorizing the Trustees of said society to execute the same.

And we do hereby covenant with the said The Iowa Seventh Day Adventist Association, a corporation, that we are lawfully seized in fee simple of said premises; that they are FREE FROM INCUMBRANCE; that we have good right and lawful authority to sell the same, and that we will WARRANT AND DEFEND the same and all appurtenances thereunto belonging, against the lawful claims of all persons whomsoever;
