

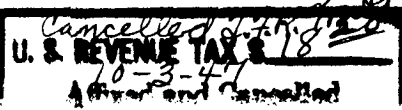

 KNOW ALL MEN BY THESE PRESENTS: THAT WHEREAS, on the 8 day of September, A. D. 1947, Myrtle Greer and T. F. Ruth as Executors of the estate of W. W. Greer, deceased, late of the County of Madison within the State of Iowa now deceased, filed his petition in the District Court of Iowa, within and for the County of Madison against Myrtle Greer, Elwood Macumber, Emma Callison, Avery Macumber, Ruth Macumber, Iris Macumber, Winifred Macumber, Mildred Macumber, Hattie Gonseth, Pearl Welch, Nellie Hess, Hyle Macumber, Otto Macumber, Callie Fredrickson, Dora Macumber, George Macumber, Albert Allen Macumber, Clarence Keith Macumber, Lydia Macumber Kenney, Myrtle Macumber Peterson, Charley Macumber, John Macumber, Clarence Macumber, Walter Macumber, Homer Macumber, Anna Hartsook, Walter Greer, Edna Stewart, Mildred Wright, Lena Covell, Roy Greer, L. James Greer, Bessie Chaney, Clara Mills, Anna Gordon, Miller Burns, Albert Burns, Charley Rippey, Frank Zeller, Armina Brownell, Willa Black, Susie Sage, Russell Cain, Ord Church of Christ, Methodist Church of Winterset, Iowa, Christian Home, Lyle Hartsook, Bill Greer, William Welsie Greer, legatees and devisees under the Last Will and Testament of W. W. Greer, deceased, praying for an order of said Court, directing him to make sale of the real estate of said decedent to-wit:

South Half of the Southeast Quarter of Section Twenty-eight (28), Township Seventy-five (75) North, Range Twenty-eight (28) West of the Fifth P. M., Madison County, Iowa.



And whereas, it appearing to the Court that a sale of said real estate was necessary to comply with the terms of the Will of said Decedent, it was by said Court ordered, adjudged and decreed that the said Myrtle Greer and T. F. Ruth, Executors, proceed to make sale of said real estate aforesaid, at private sale, at not less than the sale price agreed upon by said Executors and arbitrator selected according to said Will; and having sold said premises to C. B. Thrift for the sum of Sixteen Thousand, Four Hundred DOLLARS which sum was sale price agreed upon, and said sum having been paid by the said C. B. Thrift and whereas, the said Court afterwards approved and confirmed the sale, ordered the said Myrtle Greer and T. F. Ruth, Executors, to make and execute a deed to the said C. B. Thrift for said premises, according to the statute in such case made and provided:

NOW THEREFORE, We, Myrtle Greer and T. F. Ruth as Executors of the estate of W. W. Greer, deceased, aforesaid, in consideration of the sum of Sixteen Thousand, Four Hundred DOLLARS to me in hand paid, the receipt whereof is hereby acknowledged, and by virtue of the powers in me vested by law, and by order of said Court, do hereby grant, bargain, sell and convey unto the said C. B. Thrift the real estate aforesaid, with all and singular the appurtenances thereunto belonging. To have and to hold the same unto the said C. B. Thrift his heirs and assigns forever.
