lowing described real estate situated in Madison County, Iowa, to-wit:

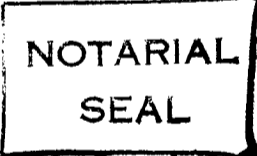
The Northeast Quarter (NE $\frac{1}{4}$) of Section Twenty (20), township 74 North, Range 27 West of
