WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That Register Life Insurance Company, a corporation organized and existing under the laws of the State of Iowa of Scott County, and State of Iowa, in consideration of the sum of One Dollar and other valuable consideration Dollars, in hand paid by Commissioner of Insurance of the State of Iowa, of Polk County, State of Iowa, do hereby sell and convey unto the said Commissioner of Insurance of the State of Iowa and/or his successors in office, in trust and to his successors and assigns, the following described premises, situated in Madison County, State of Iowa, to-wit:

The East Half of the Southwest Quarter ($E\frac{1}{2}SW\frac{1}{4}$) and the Southwest Quarter of the Southwest Quarter ($SW\frac{1}{4}SW\frac{1}{4}$) of Section 32, in Township 76 North of Range 26 West of the 5th P. M.

And we do hereby covenant with the said Commissioner of Insurance of Iowa that we are lawfully seized of said premises; that they are free from encumbrance; that we have good right and lawful authority to sell and convey the same; and we do hereby covenant to warrant and defend the said premises against the lawful claims of all persons whomsoever. And the grantor aforesaid hereby relinquishes all contingent rights, including dower and homestead, which it has in and to the said described premises.
