KNOW ALL MEN BY THESE PRESENTS: That Jefferson Township of Madison County, Iowa, by the Township Trustees George Wright, J.S.Smith and S.E.Trindle in consideration of the sum of One and no/100 Dollars in hand paid by the Jefferson U.B.Church of Jefferson Township of the County of Madison, and State of Iowa, do hereby Quit-Claim unto the said Jefferson U.B.Church all its right, title and interest in and to the following described premises situated in Madison County and State of Iowa, to-wit:

Commencing at a point 46 rods West and 2 rods North of the South East corner of the North East Quarter (N.E. $\frac{1}{4}$ ) of the South East Quarter (S.E. $\frac{1}{4}$ ) of Section Twenty Six (26), Township Seventy Seven (77) North, of Range Twenty Seven (27) West of the 5th P.M. Iowa; thence running North 14 rods to a stone at the corner of No. 2; thence West 14 rods to a stone at the corner of No.3, thence South 14 rods to a stone at the corner of No. 4, thence East 14 rods to a stone at the corner of No. 1 V 9° 30' on all lines. Said premises are hereby conveyed by the grantor to the grantee for Cemetery purposes and are to be kept and used as a public burying ground.
