Whereas, under date of July 7th, A.D. 1913 W.H. Maxwell, L.V. Price and C.D. Stiles, then Board of Supervisors of Madison County, Iowa, for the purpose of correcting the title of I.N. Norman and Leah Norman in and to the Southeast Quarter ($\frac{1}{4}$) of the North East Quarter ($\frac{1}{4}$) of Section Fourteen (14) in Township Seventy-seven (77) North, of Range Twenty-seven (27) West of the 5th P.M. as against a certain tax title to said real estate ~~deeded~~ to S.V. White under date of January 15th, 1867, and

Whereas, to carry out said purpose the said Board of Supervisors executed a certain deed to said I.N. Norman, dated July 7th, A.D. 1913 and recorded in Deed Record 34 at Page 572 of the records of the office of the County Recorder of Madison County, Iowa, and

Whereas, in the said deed so executed and recorded as aforesaid, by clerical error of the person who drew the said deed the said land was therein erroneously described as being in Section Fourteen (14) of Township Seventy-seven (77) North, of Range Twenty-six (26) West of the 5th P.M. when in truth and in fact it should have described said land as being in Range Twenty-seven (27) of said Township Seventy-seven (77), Now Therefore, for the purpose of correcting said erroneous description in said deed, and in consideration of the premises and the payments heretofore made to the Board of Supervisors of Madison County, Iowa in this matter, we C.D. Stiles, M.H. McCorkle and Alf Cox, the present duly elected, legally qualified and now acting Board of Supervisors of Madison County, Iowa do, by these presents, quit claim unto I.N. Norman and Leah Norman all right, title and interest acquired by Madison County, Iowa by conveyance from C.C. Goodale and wife, Sarah J. Goodale, in and to the South East Quarter ($\frac{1}{4}$) of the Northeast Quarter ($\frac{1}{4}$) of Section Fourteen (14) in Township Seventy-seven (77) North, of Range Twenty-seven (27) West of the 5th P.M.
