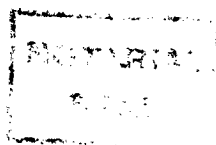
And the said Ida Comp, Nellie Comp, Gertrude Comp and Mable L. Comp hereby relinquish their right of dower in and to the above described premises.
