THIS INDENTURE,Made this first day of April,1922 by and between A.A.Dudney,R.W.McKimmy and Ruel Palmer as referees,of the first part and Jennie L.Leasman,of the second part, witnesseth:

THAT WHEREAS in an action of partition in the District Court of Madison County,Iowa, wherein Mary Leasman was plaintiff,and Charles H.Leasman,et al, defendants,the said parties of the first part were on the 7th day of December,A.D.1920,duly appointed as referees to make a sale of certain real estate situated in Madison County ,Iowa,including that hereinafter described,and it appearing to the Court that partition of said premises could not be made but that said real estate should be sold,and

WHEREAS pursuant to such order the real estate hereinafter described has been appraised for the sum of ten thousand four hundred (\$10400) dollars,and

WHEREAS the said referees pursuant to the order of Court aforesaid did heretofore sell the following described parcel of lands to-wit:

The West Half ( $W\frac{1}{2}$ ) of the Northeast Quarter ( $NE\frac{1}{4}$ ) in Section Twenty Five (25) in Township Seventy Four (74) North of Range Twenty Eight (28) West of the 5th P.M.Iowa,at private sale to Jennie L. Leasman for the appraised value thereof,to-wit: ten thousand four hundred (\$10400) dollars,and

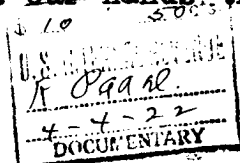

TO HAVE AND TO HOLD the same unto the party of the second part,as fully and absolutely as the said parties of the first part,by virtue of the premises,may and can sell the same.
