Wall of Alleghany County, and State of Pennsylvania, do hereby quit claim unto the said Elsie C. Wall, the undivided one-seventy second part of the following described premises situated in the County of Polk, and State of Iowa, to-wit:

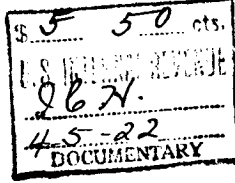
