KNOW ALL MEN BY THESE PRESENTS: THAT WHEREAS, in an action of Partition in the District Court of Madison County, Iowa, wherein W. C. Krabiell, et al were plaintiffs and Minnie Gregory, et al defendants, it was, on the second day of October 1922, in pursuance of law ordered and decreed by said Court that the real estate hereinafter described be sold on the following terms, to-wit: At public or private sale for cash. AND WHEREAS, the undersigned, W. J. Cornell, Eugene Wilson, and H. G.
